**ORDINANCE NO. 15-02**

**AN ORDINANCE AMENDING SEWER PARTICIPATION CHARGES**

**BE IT ENACTED BY THE BOARD OF DIRECTORS OF SOUTH PLACER  
MUNICIPAL UTILITY DISTRICT AS FOLLOWS:**

SECTION 1

In conformance with Section 3.01 F of Ordinance 09-02, a sewer participation charge for each equivalent dwelling unit is hereby fixed and established as follows:

<u>Implementation Date</u>	<u>Sewer Participation Charge<sup>1</sup></u>	<u>Regional Charge<sup>2</sup></u>
10/1/2015	\$3000/EDU	\$7232/EDU
10/1/2016	\$3750/EDU	

SECTION 2

Following the final implementation date of 10/1/2016, the charge should be inflated October 1 of each successive year by the change in the average of the Construction Cost Index (20-City) and the Construction Cost Index (San Francisco, CA).as reported in the Engineering News Record for the preceding year ending December.

SECTION 3

This Ordinance shall be effective 10/01/2015.

SECTION 4

Ordinance No. 09-04 adopted on June 4, 2009 and Resolution 14-01 adopted February 6, 2014 are hereby rescinded.

<sup>1</sup> Such sewer participation charge may be changed from time to time by ordinance or inflated in accordance with Section 2 of this Ordinance.

<sup>2</sup> Such regional participation charge shall be adjusted annually in conformance with the recommendation in South Placer Wastewater Authority Resolution No. 2008-01, and any amendment thereto, as follows:

“The recommended minimum Regional Connection Fee shall automatically be adjusted each July 1st based upon the Construction Cost Index for the preceding May, as published in the Engineering News Record publication, unless otherwise determined by the Board. As used herein, “Construction Cost Index” means the average of the Construction Cost Index (20-City) and the Construction Cost Index (San Francisco, CA).”

This Ordinance was introduced at a regular meeting of the Board of Directors held on the 2nd day of July, 2015.

SECTION 6

Upon final passage, this Ordinance, or a summary of this Ordinance, shall be published once a week for two successive weeks in a newspaper of general circulation within the District, pursuant to the provisions of Sections 11534 and 11910 of the Public Utilities Code.
