ORDINANCE NO. 82-1

AN ORDINANCE ADOPTING STANDARD SPECIFICATIONS
AND IMPROVEMENT STANDARDS FOR SANITARY SEWERS

BE IT ORDAINED BY THE BOARD OF DIRECTORS OF ROCKLIN-
LOOMIS MUNICIPAL UTILITY DISTRICT AS FOLLOWS:

Section 1

That certain document entitled ROCKLIN-LOOMIS MUNICIPAL UTILITY DISTRICT - STANDARD SPECIFICATIONS AND IMPROVEMENT STANDARDS FOR SANITARY SEWERS, dated 1982, prepared by Spink Corp., the District's engineers, is hereby established and adopted as the standard specifications and improvement standards for sanitary sewers in ROCKLIN-LOOMIS MUNICIPAL UTILITY DISTRICT.

Section 2

Said document consists of a table of contents consisting of 4 pages, Section 1 consisting of 10 pages, Section 2 consisting of 7 pages, Section 3 consisting of 16 pages, Section 4 consisting of 3 pages, Section 5 consisting of 22 pages, Section 6 consisting of 2 pages, and 19 Standard Drawings. Reference is hereby made to said document and by such reference each of its terms are incorporated herein as though the same were fully set forth.

Section 3

Said document is permanently on file with the Secretary of the District and is available for inspection by interested persons

during normal business hours of the District.

Section 4

Any provision of Ordinances No's 1G, 1H, 1I, 1J, or any other Ordinance of ROCKLIN-LOOMIS MUNICIPAL UTILITY DISTRICT which is inconsistent with any provision of the document referred to in Sections 1 and 2 hereof, is hereby repealed.

Section 5

Any provision of the document referred to in Sections 1 and 2 hereof may be amended at any time by resolution of the Board of Directors.

Section 6

This Ordinance shall be in effect from and after the date of its final passage.

This Ordinance was introduced on motion of Director Howard, seconded by Director Lemos, and carried unanimously at a regular meeting of the Board of Directors of ROCKLIN-LOOMIS MUNICIPAL UTILITY DISTRICT on the 6th day of May, 1982.
