

**SOUTH PLACER MUNICIPAL

**ORDINANCE NO. 09-04**

**AN ORDINANCE RELATING TO PARTICIPATION CHARGES**

**BE IT ENACTED BY THE BOARD OF DIRECTORS OF SOUTH PLACER  
MUNICIPAL UTILITY DISTRICT AS FOLLOWS:**

SECTION 1

In conformance with Section 3.01 F of Ordinance 09-02, a basic participation charge for each equivalent dwelling unit is hereby fixed and established as follows:

<u>Fiscal Year</u>	<u>Local Charge (1)</u>	<u>Regional Charge (2)</u>
2009-2010	\$2,000.00	\$6247.00
2010-2011	\$2,250.00	
2011-2012	\$2,500.00	
2012-2013	\$2,500.00	
2013-2014	\$2,500.00	

(1) Such basic local participation charge may be changed from time to time by ordinance.

(2) Such basic regional participation charge shall be adjusted annually in conformance with the recommendation in South Placer Wastewater Authority Resolution No. 2008-01, and any amendment thereto, as follows:

“The recommended minimum Regional Connection Fee shall automatically be adjusted each July 1<sup>st</sup> based upon the Construction Cost Index for the preceding May, as published in the Engineering News Record publication, unless otherwise determined by the Board. As used herein, “Construction Cost Index” means the average of the Construction Cost Index (20-City) and the Construction Cost Index (San Francisco, CA).”

SECTION 2

This Ordinance shall be effective retroactive to July 1, 2009.

SECTION 3

Ordinance No. 08-01 adopted on June 5, 2008 is hereby rescinded.

SECTION 4

This Ordinance was introduced at a regular meeting of the Board of Directors held on the 4<sup>th</sup> day of June, 2009.

SECTION 5

Upon final passage, this Ordinance, or a summary of this Ordinance, shall be published once a week for two successive weeks in a newspaper of general circulation within the District, pursuant to the provisions of Sections 11534 and 11910 of the Public Utilities Code.
