#### ORDINANCE NO. 03-01

### AN ORDINANCE RELATING TO PARTICIPATION CHARGES AND MONTHLY SERVICE CHARGES

## BE IT ENACTED BY THE BOARD OF DIRECTORS OF SOUTH PLACER MUNICIPAL UTILITY DISTRICT AS FOLLOWS:

#### SECTION 1

In conformance with Section 52 of Ordinance No. 01-01, a basic participation charge for each equivalent dwelling unit is hereby fixed and established as follows:

#### Section 2

In conformance with Section 53 of Ordinance No. 01-01, a monthly service charge for each equivalent dwelling unit is hereby fixed and established as follows:

#### Section 3

Said local share of the participation charge and/or monthly service charge may be changed from time to time by ordinance.

#### Section 4

This ordinance shall be effective retroactive to July 1, 2003.

#### Section 5

Ordinance No. 98-01 adopted on July 2, 1998, and Ordinance No. 01-02 adopted on November 1, 2001 are hereby rescinded.

#### Section 6

This ordinance was introduced at a regular meeting of the Board of Directors held on the <u>7th</u> day of <u>August</u>, 2003.

#### Section 7

Upon final passage, this ordinance shall be published once a week for two successive weeks in a newspaper of general circulation within the District, pursuant to the provisions of Sections 11534 and 11910 of the Public Utilities Code.

#### Board of Directors:

Pursuant to the provisions of Section 14401 of the Public Utilities Code and based on the Bartle Wells Associates Report, <u>South Placer M.U.D.</u> Wastewater Financing Plan <u>Update</u>, dated June 2003, it is my recommendation that the District's Monthly Service Charge per EDU be established in accordance with the following schedule:

Also, pursuant to the provisions of Section 14401 of the Public Utilities Code, and the Bartle Wells Associates Report mentioned above, and Sections 9b(2) and 10c of the Funding Agreement of the South Placer Wastewater Authority, dated October 1, 2000, it is my recommendation that the District's Participation Charge per EDU be established in accordance with the following schedule:
