ORDINANCE NO. 08-01

**AN ORDINANCE RELATING TO PARTICIPATION CHARGES
AND MONTHLY SERVICE CHARGES**

**BE IT ENACTED BY THE BOARD OF DIRECTORS OF SOUTH PLACER
MUNICIPAL UTILITY DISTRICT AS FOLLOWS:**

Section 1

The basic participation charge previously fixed and established for each equivalent dwelling unit under Ordinance 03-01, is hereby fixed and established as follows:

| <u>Fiscal Year</u> | <u>Local Charge</u> | <u>Regional Charge</u> |
|--------------------|---------------------|--------------------------|
| 2008-2009 | \$ 1,500.00 | \$ 5,815.00 ¹ |

¹ Plus increases as recommended to the District by the South Placer Wastewater Authority.

The participation charge for Fiscal Year 2008-2009 shall continue in effect for each Fiscal Year thereafter until such time as it is changed by ordinance.

Section 2

The monthly service charge previously fixed and established for each equivalent dwelling (EDU) unit under Ordinance 06-01, is hereby fixed and established as follows:

| <u>Fiscal Year</u> | <u>Monthly Charge</u> |
|--------------------|-----------------------|
| 2008-2009 | \$20.50 |

The monthly service charge for Fiscal Year 2008-2009 shall continue in effect for each Fiscal Year thereafter until such time as it is changed by ordinance.

The monthly service charge for multiple dwelling units shall be the basic EDU rate multiplied by the number of equivalent dwelling units.

Section 3

This ordinance shall be effective July 1, 2008.

Section 4

Ordinance No. 03-01 adopted on September 4, 2003, and Ordinance No. 06-01 adopted on September 7, 2006 are hereby rescinded.

Section 5

This ordinance was introduced at a regular meeting of the Board of Directors held on the 1st day of May, 2008.

Section 6

Upon final passage, this ordinance shall be published once a week for two successive weeks in a newspaper of general circulation within the District, pursuant to the provisions of Sections 11534 and 11910 of the Public Utilities Code.
