ORDINANCE No. 93-1

AN ORDINANCE AMENDING SECTIONS 52 and 53 OF ORDINANCES NO. 90-1 AND 92-1 RELATING TO PARTICIPATION CHARGES AND MONTHLY SERV-ICE CHARGES FOR SERVICE AND SERVICES RENDERED BY SOUTH PLACER MUNICIPAL UTILITY DISTRICT

BE IT ENACTED BY THE BOARD OF DIRECTORS OF SOUTH PLACER MUNI-CIPAL UTILITY DISTRICT AS FOLLOWS:

Section 1

Section 52 of Ordinances 90-1 and 92-1 is hereby amended to read as follows:

Section 52:

A basic participation charge for each equivalent dwelling unit is hereby fixed and established as follows:

- (a) For the fiscal year 1993-1994\$4,000.00
- (b) For the fiscal year 1994-1995 . . . 4,050.00
- (c) For the fiscal year 1995-1996 . . . 4,100.00
- (d) For the fiscal year 1996-1997 . . . 4,150.00
- (e) For the fiscal year 1997-1998 . . . 4,200.00

Section 2

Section 53 of Ordinance 90-1 is hereby amended to read as follows:

Section 53:

A monthly service charge for each equivalent dwelling unit is hereby fixed and established as follows:

(a) For the fiscal year 1993-1994 \$12.00 per month

(b) For the fiscal year 1994-1995 13.00 per month

(c) For the fiscal year 1995-1996 14.00 per month

(d) For the fiscal year 1996-1997 15.50 per month

(e) For the fiscal year 1997-1998. 16.50 per month

Such monthly service charge may be changed from time to time by ordinance. The monthly service charge for multiple dwelling units shall be the basic EDU rate multiplied by the number of equivalent dwelling units.

Section 3

This Ordinance shall be effective from and after the first day of July, 1993.

Section 4

This Ordinance was introduced at a special meeting of the Board of Directors held on the 24th day of May, 1993.

Section 5

Upon final passage, this Ordinance shall be published once a week for two successive weeks in a newspaper of general circulation within the District, pursuant to the provisions of Sections 11534 and 11910 of the Public Utilities Code.

Recommendations Regarding the Increase in the Monthly Service Charge and Line Extension Portion

of the Participation Charge

Board Members:

Pursuant to the provisions of Section 14401 of the Public Utilities Code, and based on the Bartle-Wells Associates report, S/PMUD Five Year Wastewater Financing Plan, dated April, 1993, it is my recommendation that the portion of the District's participation charge representing the Line Extension Fund be raised to \$1250/EDU for the 1993/94 fiscal year, and be increased by \$50/EDU each fiscal year thereafter through 1997/98.

Also pursuant to Section 14401, and based on information furnished by our Financial Consultant, I hereby recommend that the District's monthly service charge per EDU be raised and established in accordance with the following schedule:

> \$12/mo. (1993/94) \$15.50/mo. (1996/97) \$13/mo. (1994/95) \$16.50/mo. (1997/98) \$14/mo. (1995/96)

A copy of the Bartle-Wells financing plan is attached hereto and made a part hereof.

The above mentioned Section of the Public Utilities Code requires the Board to hold a public hearing within 40 days of the filing of this Report and Recommendation, and that notice of the time and place of the hearing shall be published once a week for The Attorney for the District will prepare the required two successive weeks. Notice of Hearing for this purpose.
