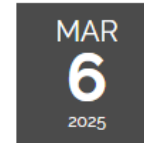
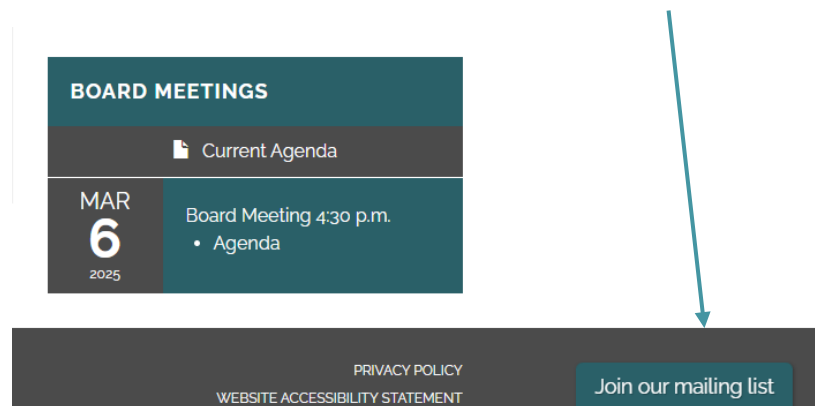

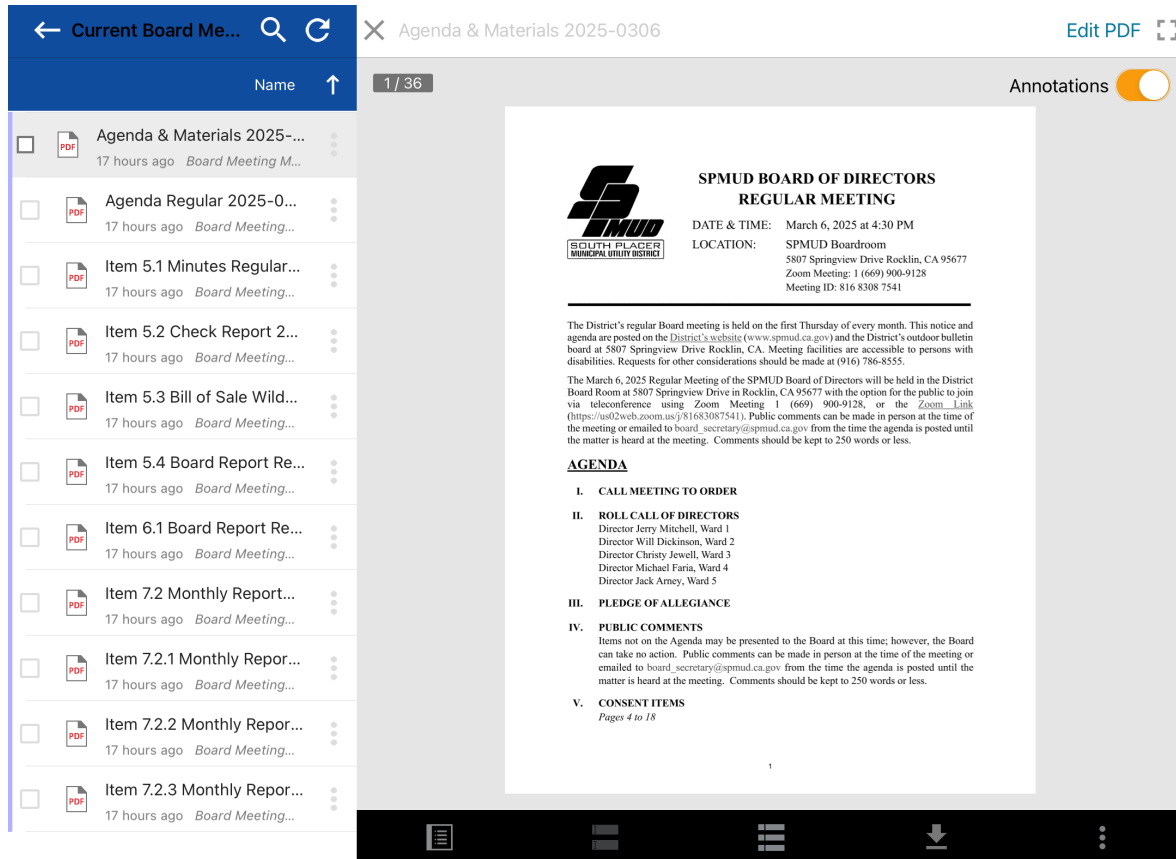
Note that the public will be muted by default. If you would like to speak during the public comment portion of the meeting, you have the following options:
