ORDINANCE NO. 96-1

AN ORDINANCE AMENDING SECTION 2 OF
ORDINANCE 93-1 RELATING TO MONTHLY SERVICE
CHARGES FOR SERVICE AND SERVICES RENDERED BY THE
DISTRICT FOR THE FISCAL YEAR 1996-1997

BE IT ENACTED BY THE BOARD OF DIRECTORS OF SOUTH PLACER MUNICIPAL UTILITY
DISTRICT AS FOLLOWS:

SECTION 1

Section 2 of the Ordinance 93-1 is hereby amended to read as follows:

Section 53:

A monthly service charge for each equivalent dwelling
unit is hereby fixed and established as follows:

- (a) For the fiscal year 1993-1994.....\$12.00 per month
- (b) For the fiscal year 1994-1995.....\$13.00 per month
- (c) For the fiscal year 1995-1996.....\$14.00 per month
- (d) For the fiscal year 1996-1997.....\$14.00 per month
- (e) For the fiscal year 1997-1998.....\$16.50 per month

Such monthly service charge may be changed from time to
time by ordinance. The monthly service charge for
multiple dwelling units shall be the basic EDU rate
multiplied by the number of equivalent dwelling units.

SECTION 2

This Ordinance shall become effective retroactive to July 1, 1996.

SECTION 3

This Ordinance was introduced at a regular meeting of the Board of
Directors held on the 11th of July, 1996.

SECTION 4

Upon final passage, this Ordinance shall be published once a week for two
successive weeks in a newspaper of general circulation within the District,
pursuant to the provisions of Sections 11534 and 11910 of the Public Utilities
Code.



Subject: Recommendation Regarding the 1996-97
Monthly Service Charge

Board Members:


In accordance with Ordinance 93-1, the monthly service charge is scheduled to automatically increase \$1.50 to \$15.50/month on July 1, 1996. The \$15.50 rate is to be in effect for the 1996-97 fiscal year.

After review and discussion at the June 24, 1996 budget workshop, staff and the Board determined that the proposed revenues for 1996-97, at the existing rate of \$14.00/month would be adequate to meet expected expenses; and that with the existing rate it is projected that General Fund reserves, at the end of the 1996-97 fiscal year, will be within the guidelines established in the S/PMUD Five Year Wastewater Financing Plan, dated April, 1993.

Pursuant to provisions of Section 14401 of the Public Utilities Code, and based on the guidelines established in the District's financing plan and information provided at the June 24, 1996 budget workshop, I hereby recommend that the District's monthly service charge per EDU remain at the existing rate of \$14.00/month for the 1996-97 fiscal year.

The above mentioned Section of the Public Utilities Code requires the Board to hold a public hearing within 40 days of the filing of this Report and Recommendation, and that notice of the time and place of the hearing shall be published once a week for two successive weeks. The District will prepare the required Notice of Hearing for this purpose.
