WHEREAS, a petition, addressed to the Board of Directors of the ROCKLIN- LOOMIS MUN-ICIPAL UTILITY DISTRICT, describing SUNSET CITY UN-INCORPORATED TERRITORY and requesting that proceedings be taken for their annexation to said District has been filed with the Secretary of said District and said Secretary has ascertained and determined that said petition has been signed by all of the owners of the real property described therein and duly verified by the Affidavit of one of the petitioners, and said Secretary has attached his signature to said petition and presented the same to said Board of Directors, and

WHEREAS, said Board of Directors has duly investigated and considered the advisability of annexing said territory and the terms and conditions upon which such annexation should be made;

NOW, THEREFORE, BE IT ENACTED BY THE BOARD OF DIRECTORS OF THE ROCKLIN-LOOMIS MUNICIPAL UTILITY DISTRICT:

SECTION 1. That the annexation of SUNSET CITY UNINCORPORATED TERRITORY will facilitate the operation of a public utility by said District and be of advantage to said District and that such territory should be annexed to said District upon the terms and conditions hereinafter set forth in Section 2.
