### SIGN UP FOR PAPERLESS BILLING

SPMUD offers paperless billing to the email address of your choice. Currently, only 18% of District customers are signed up to receive e-bills. Opting out of paper billing statements is good for the environment and helps keep rates low.

### SEWER DOS AND DON'TS

The South Placer Municipal Utility District performs routine maintenance on sewer mains and lower laterals to keep them flowing freely. We inspect and clean the lines on a scheduled basis. Here are some things that you can do to help maintain the sewer:



#### Do:

- Call us if you have any questions about your sewer line.
- Obtain a sewer permit from us if you need to make a lateral repair.
- Only use a licensed contractor to make necessary repairs.
- Consider installing a backflow preventer to prevent flooding in your home or building.
- Recycle oil, paint, and other toxic materials at a recycling center.
- Remember that storm drain lines, streets, sidewalks, and trees in public rights-of-way are maintained by the Cities and Towns.



#### Do Not:

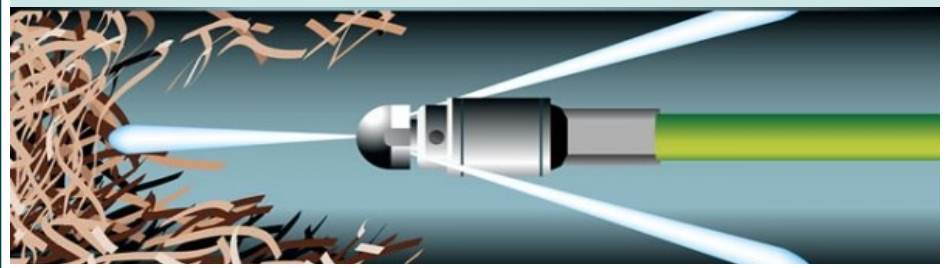
- Put grease, oil, milk products, egg shells, or food stickers down drains or in garbage disposals.
- Flush wipes even if the package says that they are flushable.
- Plant a tree directly over a sewer line. Roots can be problematic.
- Dig without calling Underground Service Alert at 811.
- Proceed automatically with an expensive repair. Please call us first.
- Bury or cover the cleanout in front of your building.
- Open a manhole for any reason. We will do this for you.

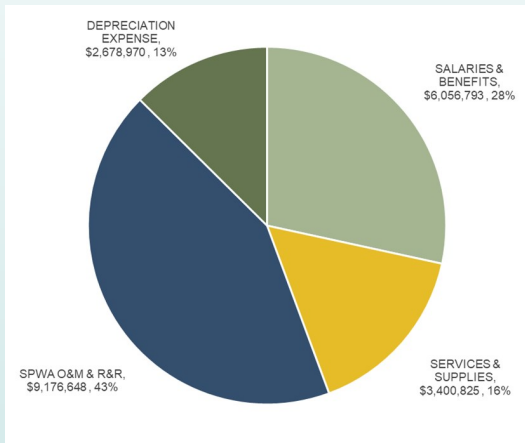
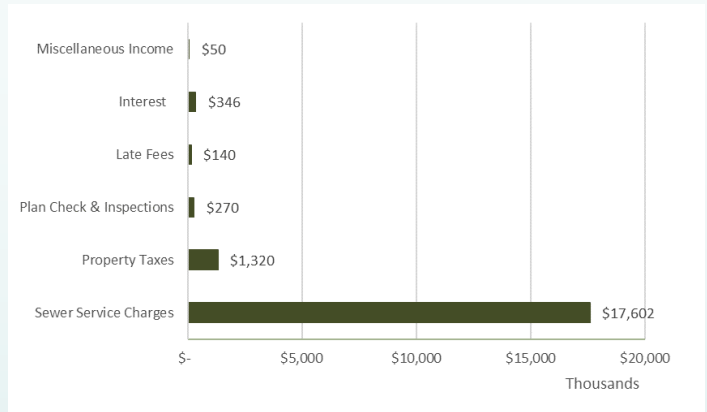

**BUDGET IN BRIEF**

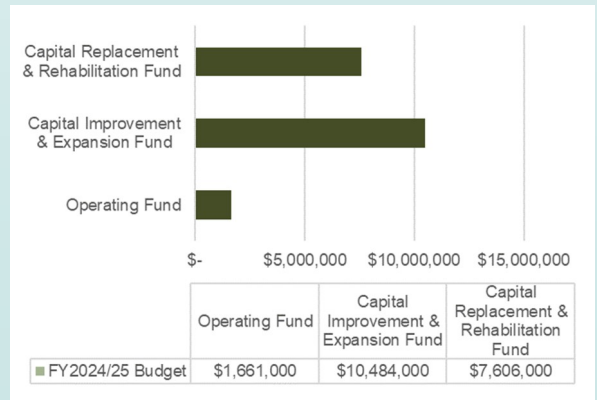
The District’s Board of Directors adopted the Fiscal Year 2024/25 Budget and Proposed Spending Plan.

**REVENUES:** Operating Fund revenues are comprised of monthly service fees, other service fees, property taxes, and interest revenues. The District has the lowest monthly residential customer service fees in the region at \$38.94 a month. Operating Fund revenues are projected to be \$19.80 million.



**OPERATING EXPENSES:** The budget allocates 43% of the operating fund expenses to Regional Wastewater Treatment operated by the City of Roseville and financed through the South Placer Wastewater Authority. Local collection system operations & maintenance and repair & rehabilitation make up the remaining 57% of the spending plan. Operating Fund expenses are projected to be \$21.31 million and include the use of one-time reserve spending to complete programmed system improvements.

**CAPITAL EXPENSES:** Major Capital Expenses include the Taylor Road Crossing and Old State Highway and Buena Vista Sewer Replacement projects in Newcastle, Participation in Regional Projects, Trunk Extension Reimbursements, SCADA Implementation, Cured-in-Place Pipe, Vehicle Purchases, Easement Upgrades, and System Rehabilitation Projects. Capital Fund expenses are projected to be \$19.75 million.



**Board Meetings:**

SPMUD is an independent public agency governed by an elected Board of Directors. Directors represent each of the five wards within the District and are elected by voters to four year terms.
