## **ORDINANCE NO. 17-03**

# AN ORDINANCE AMENDING ORDINANCE 15-02 UPDATING SEWER PARTICIPATION CHARGES

# BE IT ENACTED BY THE BOARD OF DIRECTORS OF SOUTH PLACER MUNICIPAL UTILITY DISTRICT AS FOLLOWS:

#### SECTION 1

In conformance with Ordinance 15-02 and Section 3.01 F of Ordinance 09-02, a sewer participation charge for each equivalent dwelling unit was hereby fixed and established as follows:

Implementation Date	Sewer Participation Charge <sup>1</sup>	Regional Charge <sup>2</sup>
October 1, 2016	\$3750/EDU	\$7634/EDU

#### **SECTION 2**

Section 2 of Ordinance 15-02 is hereby rescinded.

#### SECTION 3

Following the implementation date of October 1, 2016, the sewer participation charge shall be adjusted effective July 1, 2018 by the change in the average of the Construction Cost Index (20-City) and the Construction Cost Index (San Francisco, CA), as reported in the Engineering News Record for the preceding 19-month period ending in May, 2018.

#### SECTION 4

So as to coincide with the annual adjustment of the regional participation charge established by the South Placer Wastewater Authority for regional sewage treatment, following the implementation date of July 1, 2018, the sewer participation charge shall be adjusted on July 1 of each successive year by the change in the average of the Construction Cost Index (20-City)

<sup>&</sup>lt;sup>2</sup> Such regional participation charge shall be adjusted annually in conformance with the recommendation in South Placer Wastewater Authority Resolution No. 2008-01, and any amendment thereto, as follows:

<sup>&</sup>quot;The recommended minimum Regional Connection Fee shall automatically be adjusted each July 1st based upon the Construction Cost Index for the preceding May, as published in the Engineering News Record publication, unless otherwise determined by the Board. As used herein, "Construction Cost Index" means the average of the Construction Cost Index (20-City) and the Construction Cost Index (San Francisco, CA)."

and the Construction Cost Index (San Francisco, CA) as reported in the Engineering News Record for the preceding 12-month period ending the prior May.

### SECTION 5

This Ordinance shall go into effect on November 1, 2017.

### **SECTION 6**

This Ordinance was introduced at a regular meeting of the Board of Directors held on the  $7^{th}$  Day of September 2017.

### **SECTION 7**

Upon final passage, this Ordinance, or a summary of this Ordinance, shall be published once a week for two successive weeks in a newspaper of general circulation within the District, pursuant to the provisions of Sections 11534 and 11910 of the Public Utilities Code.
